This Wood-Destroying Insect Inspection Class will:

- ✓ Meet the mandatory 5-hour training required for a wood-destroying insect inspection license from the State of Ohio for houses and buildings that are being bought or sold.
- ✓ Prepare participants to take the Category 12 exam (Wood-Destroying Insect Inspections) required for the state license.
- ✓ Review and explain the documents and records required by the State of Ohio.
- ✓ Review the biology and life cycles of termites and other wood-destroying insects.

Special Note: There is **NO** direct supervision in the wood-destroying insect inspection category. All people performing inspections **MUST** be licensed.

Recertification credit: This training is also available to licensed applicators with Category 12 on their license if space is available. They will receive credit for 1 hour of core, 2 hours of category 10b (termite) and 2 hours of category 12 (WDI) for a total of 5 hours of recertification. Registration for recertification is limited and preference is given to those attending for initial training.
