### DIRECTIONS FOR USE

### RESTRICTIONS AND LIMITATIONS

- DO NOT apply more than 1 application at 12 fluid ounces per acre per year.
- DO NOT apply this product to actively growing desirable plants.

### APPLICATION INFORMATION

This product offers preemergence and postemergence control of susceptible grasses and broadleaf weeds and provides an additional mode of action to assist in the control of resistant weeds. The length of preemergence control is dependent on the rate applied as well as on rainfall and temperature conditions. Length of preemergence control will decrease as temperature and precipitation increase.

Use SureGuard SC to control weeds in naturalized areas on golf courses – these areas include low input plant stands adjacent to roughs, fairways, tees, and greens. Plant species in these areas may include cool and/or warm season grasses and broadleaves. These applications can provide early postemergence control of annual grasses and broadleaves present at time of application and preemergence control of weeds that have not yet germinated.

### NON-DORMANT AND DORMANT DIRECTED APPLICATIONS

SureGuard SC can be used during the growing season in thin open naturalized areas where directed applications can avoid desired species.

### DORMANT APPLICATIONS

In thicker naturalized areas, over the top applications can be used when desired species are completely dormant in late fall and/or winter seasons or early spring season. Avoid applications of SureGuard SC over the top of any plant stands that are actively growing. For over the top applications, all plants must be established for at least one growing season before SureGuard SC can be applied.

SureGuard SC will control newly germinated wild flowers as well as any other seeded or self-seeding species – applications should be avoided when seed germination and survival is desired.

Apply 8 to 12 fluid ounces (0.25 to 0.38 pounds ai per acre) of this product per broadcast acre plus a surfactant (0.25% v/v non-ionic surfactant). Moisture is necessary to activate this product for residual weed control. Dry weather following application may reduce effectiveness. However, when adequate moisture is received after dry conditions, this product will control susceptible germinating weeds. Thorough spray coverage is necessary to maximize the postemergence activity of this product. The addition of a surfactant enhances the activity on emerged weeds. Small emerged weeds are controlled postemergence with this product, however, translocation of this product within a weed is limited, and control is enhanced by thorough spray coverage and by the addition of a surfactant. The most effective postemergence weed control with this product occurs when applied in combination with a surfactant to weeds less than 2 inches in height.

### USE AROUND PUTTING GREENS, FAIRWAYS, and TEES

This product has limited potential for lateral movement on level terrain but can potentially move down slope after excessive rainfall and affect sensitive turf species. When applied upslope from putting greens, tees, or fairways, allow an adequate buffer zone between these areas and treated turf. If uncertain about the size of the buffer, 15 feet is suggested.

Risk of movement is decreased when this product is applied to soil at less than field capacity. Avoid application when heavy rain is imminent or when the soil is saturated.

#### **TANK MIXING WITH OTHER TURFGRASS HERBICIDES**

For postemergence control of broadleaf weeds during directed applications when weeds and desired species are actively growing, tank mix with Millennium Ultra 2 according to its label directions.
